- **Successful completion of the EFQM Foundation Certification exam** – You must complete the exam with a pass mark of 60% and above
- **Successful completion of the EFQM Certified Assessor exam** – You must complete the exam with a pass mark of 60% and above

If you do not meet these criteria, you will receive a Certificate of Attendance issued by Informa Connect Academy. If you have not attended all of the course, the certificate will clearly state the number of hours attended.

You will be allocated one hour for the exam which will consist of multiple-choice questions.

If you are unable to succeed in the first attempt, you will be provided with one attempt to retake the exam at no additional charge. This re-sit can be taken within one month of completion of the course.
