Climate fundraising has shown steady growth and resilience, with capital raised increasing 41% from 2021 to 2023, while broader industry fundraising fell 33%. Climate investing is outpacing the global market across all investment stages Capital, deal count, and deal size typically increased at double-digit rates from 2018 to 2023 across venture capital (VC), growth equity, private equity (PE), and general debt asset classes.
