## VACCINATION STATUS

Effective September 22, 2021 as per Ontario government guidelines, proof of vaccination and photo identification with name, date of birth, photo, signature (driver's license, passport) is required to access indoor events. These guidelines will apply to all attendees of the Event. Proof of vaccination is mandatory - no exceptions\*.

Evidence of vaccination will be required prior to name badge collection follows:

- 1. Proof of being fully vaccinated with final vaccine taking place at least 14 days prior to the first day of the Event\*\*
- 2. (i.e. the full series of a COVID-19 vaccine authorized by Health Canada, or any combination of such vaccines per Ontario government guidelines at time of event)
- 3. Photo ID will be required in tandem
- 4. Form confirming
- 5. Upon proof of vaccination with ID a wrist band and name badge will be provided this name badge and wrist band must be worn for duration of the event for access to rooms and networking areas (no exceptions)
- \* Anyone who registers for the Event in-person element and who is unable (for any reason) to provide a valid proof of vaccination together with associated ID will be provided with virtual access to the event, and inperson access will be withdrawn. Refunds will not be given.
- \*\* An individual is considered fully vaccinated if they have received no less than 14 days prior to presenting at the event as follows:
  - the full series of a COVID-19 vaccine authorized by Health Canada, or any combination of such vaccines,
  - one or two doses of a COVID-19 vaccine not authorized by Health Canada, followed by one dose of a COVID-19 mRNA vaccine authorized by Health Canada, or
  - three doses of a COVID-19 vaccine not authorized by Health Canada: and
  - they received their final dose of the COVID-19 vaccine at least 14 days before providing the proof of being fully vaccinated.

Health Canada approved vaccines:

- 2 doses: Pfizer-BioNtech, Moderna, AstraZeneca/COVISHIELD
- 1 dose: Janssen/Johnson & Johnson
- mRNA vaccine: Pfizer-BioNtech, Moderna (<u>https://www.health.gov.on.ca/</u>)

#### MASK PROTOCOL

In full accordance with Ontario government guidelines in place at the time of the event – anticipate face masks be worn by all – no exceptions. Anyone in non-compliance will have access to the event withdrawn. Refunds will not be given.
